ARTS 240: Introduction to New Media

Description:

This course is a broad survey of the history, theory and practice of New Media forms. Different models of professional practice, including studio and client driven practices, will be explored through lecture, discussion and research components. Students will also be introduced to the use of some common new media tools.

We will be covering a great deal of material that you will be expected to recall throughout your tenure as a candidate for an undergraduate degree in New Media. Though there will be no tests in this course, you are strongly encouraged to take notes and begin making a habit of collecting names, references, and vocabulary for later use.

Activities:

This course will entail a great deal of reading, discussion, and research. Each week you will be assigned readings, response questions, and research tasks involving the collection and sharing of examples in practice. In addition to weekly reading and writing assignments, you will be expected to keep an online journal or journals via a blog. A final project will involve the assembly of an annotated reference collection that relates to some of your more specific interests in New Media. You will also be expected to attend a few out-of-class events, typically on Wednesday evenings.

Expectations:

Timely attendance is mandatory. Writing assignments will not be accepted late. You will be expected to have read each week's course material in time for our discussion. Participation in class discussions is also required. Your grade will be determined thusly:

Attendance (10%)
Participation in class discussions (20%)
Completion of weekly writing and research assignments (40%)
Final Project (30%)

Required Texts:

Blais and Ito, <u>At The Edge of Art</u> - available at campus textbook stores Arjen Mulder, <u>Understanding Media Theory</u> - out of print. I have copies for loan a passing grade for this course is contingent upon your return of the book in good condition.

MIDTERM PAPER

You are to write a paper of at least 3 pages that applies specific, cited texts from Mulder to interpret one of the artworks I have selected.

I have selected these works because they are in some ways about media, and are often cited as influential on media art. The works I've selected are, admittedly, very arty, and not representative of the scope of practice that might fall under the heading "New Media." There's nothing here, for example, that might count as commercial design. But these works have all been influential on a wide variety of practices. You should really know about them all.

I've also chosen them because they are to be found in multiple forms. Some portion of your paper should be concerned with comparison of the piece in different forms and media.

You may rely on outside sources, but you should cite them. The application of Mulder's text to your interpretation should be the focus! Don't just explain the works based on what you read of others' interpretations.

I advise that you scan back through your notes from the class, and through the book. Look at some of the main points we've covered, think of some of the language we've been using from Mulder to talk about Media.

CHOOSE ONE FROM THESE THREE. Compare at least the versions I've cited. You may add more versions in the comparison if you can find them.

I would also recommend that you try and listen to recordings of this performance in multiple formats. Go to the Music Library, listen to some on Record, compare it to the experience of listening on an Mp3 or CD.

FINAL PROJECT: Annotated Bibliography

Create a Bibliography of references that charts a course of exploration related to your interests in New Media. Think of this as a way of narrowing the field of New Media to one you would like to learn about and improve your skills within over the next few years. Think of this as marking out a route you might want to follow out of school, or at least a course toward a Senior Thesis project.

Your sources could include:

Books of essays
Anthologies of literature
theoretical works
articles
whole magazines
email listservs
websites / blogs
biographies
supply catalogs
novels
how-to-guides

people
museums or galleries
research institutions
Compilations in video or sound
design firms
record labels
whole archives and collections
exhibition catalogs
"for dummies" - style guides
technical manuals

You need not have read everything you include - this is a list of things to be explored, not already explored. For each entry, write 1-3 lines explaining the source and its possible relationship to your topic, interests.

Pay the most attention to how your bibliography describes a specific set of concerns and interests. We should be able to read it and get a picture of a particular aspect of New Media, in terms of medium, content, context.

Your project should be at least 3 pages in length, and submitted as a Word file via email. Use the MLA guidelines for bibliographic entry, even if you have to stretch them to fit some of your sources.
